#### What data do we collect?

AGöRA collects the following data:

• Personal identification information (Name, email address, phone number, etc.)

#### How do we collect your data?

You directly provide AGöRA with most of the data we collect. We collect data and process data when you:

· Register online or place an order for any of our products or services.

• Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.

• Use or view our website via your browser's cookies.

## How will we use your data?

AGöRA collects your data so that we can:

- · Process your order and manage your account.
- · Email you with special offers on other products and services we think you might like.

If you agree, AGöRA will share your data with our partner companies so that they may offer you their products and services.

When AGöRA processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

#### How do we store your data?

AGöRA securely stores your data at the secure provided by the web server company. AGöRA will keep your contact data for 5 years after finishing our commercial relation. Once this time period has expired, we will delete your data by erasing from our server.

# What are your data protection rights?

AGöRA would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request AGöRA for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** – You have the right to request that AGöRA correct any information you believe is inaccurate. You also have the right to request AGöRA to complete the information you believe is incomplete. **The right to erasure** – You have the right to request that AGöRA erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that AGöRA restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to AGöRA's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that AGöRA transfer the data that we have collected to another organization, or directly to you, under certain conditions.
